## Court sends Tahir Hussain to 4-day custody

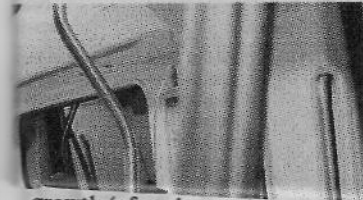

A Delhi court on Monday sent suspended AAP councillor Tahir Hussain to four-day police custody in connection with the alleged killing of

Intelligence Bureau official Ankit Sharma during the recent communal violence in north-east Delhi. Chief Metropolitan Magistrate Pawan Singh Rajawat sent Hussain for interrogation after police sought his custody for five days. Hussain

was booked for his alleged role in the murder of the IB staffer during the communal riots that rocked the city last month.

The AAP had then suspended him for alleged involvement in the violence which has left at least 53 people dead.
